Notes:

- 1. The Act sets the deadline as the last day of February, which falls on February 29 in leap years.
- 2. The March 5 deadline is based on the fifth business day of March. This may fall on March 5, 6, or 7. *Hospitals must meet and maintain the required average by March 25, 2025.
- 3. The Conservation and Demand Management (CDM) plan must be completed every five years. The previous plan was due July 2024 and the next is due July 2029.
- 4. The Registered Charity Information Return is only required for hospitals that are registered charities.
- 5. Accessibility Compliance Reports are due every two years. The next report must be submitted by December 31, 2025.
