# **COVID-19** Assessment Centres at Unity Health – St. Michael's and St. Joseph's sites

#### Updated: March 24, 2020 at 6:34 PM

### Background

Since January 2020, there has been sustained global spread of the coronavirus known as COVID-19. Unity Health Toronto has taken a number of steps to prepare for the potential presentation of COVID-19 at one of our sites including refresher education on appropriate use of PPE and hand hygiene as well as routine practices and procedures.

As the outbreak continues to evolve globally and locally within Toronto, the St. Joseph's and St. Michael's sites at Unity Health have opened COVID-19 Assessment Centre in the Sunnyside Building and in the Li Ka Shing Knowledge Institute, where those with suspected cases of COVID-19 will go for assessment and testing.

As new directives have been released by Toronto Public Health, the materials in this plan have been updated accordingly and some communications materials have been added to announce directive changes.

### **Communication Objectives**

- 1. Reassure stakeholders that Unity Health is capable in providing effective, safe care to patients presenting with COVID-19
- 2. Reassure staff, physicians, learners and volunteers of their safety in providing care to patients presenting with COVID-19
  - a. Reassure those who will continue to work and learn in the Sunnyside building of their safety
- 3. Reassure patients they will continue to receive the same excellent care regardless of whether patients with COVID-19 are present or have presented at Unity Health
  - a. Reassure those who will continue to receive care/see physicians in the Sunnyside building of their safety
- 4. Recognize teams for following appropriate guidelines and practices
- 5. Share resources for internal stakeholders needing additional support
- 6. Direct external stakeholders to appropriate resources (i.e. Toronto Public Health)
- 7. Stay connected with TAHSN colleagues to ensure consistent messaging

#### Dear physicians,

As you know, the COVID-19 situation continues to evolve. To help protect our patients, people and communities, we are opening two COVID-19 Assessment Centres – one at St. Joseph's and one at St. Michael's in partnership with Public Health.

The Assessment Centre at St. Joseph's Health Centre will be located on the first floor of the Sunnyside building on the east side. As the Sunnyside building is an area you work and practice in, we are connecting with you and reassure you that steps have been taken so that this will not impact your safety or the safety of your patients in any way.

Starting on Monday, March 16, we will ask you to please use the west entrance to Sunnyside when possible and encourage your patients to do the same. We are finalizing hours – the centre will be open from 10 to 12 hours a day based on volumes and need to help manage flow and reduce pressure in our Emergency Departments. Once patients are screened and assessed, any who test positive will receive directives from clinicians and will be cared for appropriately. This location will provide a safe and isolated environment for screening of patients and was chosen because we are able to seal the space off safely to protect our people and other patients who will be entering the building. Should your office identify any patients with a positive travel history and or symptoms please direct them to the assessment centre.

To help keep our patients, staff and visitors safe, we have opened a COVID-19 Assessment Centre at our St. Michael's and St. Joseph's sites, where anyone in our community who has concerns about their symptoms can be assessed.

Accessing our COVID-19 Assessment Centre is the easiest and safest way for you to receive screening and assessment for COVID-19 at St. Michael's Hospital and St. Joseph's Health Centre. These Assessment Centres are equipped with proper precautions such as hand hygiene stations and isolated spaces for those who are being assessed for COVID-19.

#### How do I access the Assessment Centre?

- At St. Michael's: The Assessment Centre is located in the Li Ka Shing Knowledge Institute on 38 Shuter St. (East building). Patients accessing the Assessment Centre will be asked to line up at this entrance. Please note no visitors are to accompany those who require screening.
- At St. Joseph's: The Assessment Centre is located in the Sunnyside Building on the 1<sup>st</sup> floor, through the entrance off of Sunnyside Ave. (east side of the building). Please note no visitors are to accompany those who require screening.

#### What are the hours?

At St. Joseph's, the Assessment Centre is open from 9 a.m. to 9 p.m. and at St. Michael's the Assessment Centre is open from 9 a.m. to 7 p.m.

#### When should I come to an assessment centre?

In alignment with new Toronto Region COVID-19 Hospital Operations group guidelines, COVID-19 Assessment Centres will now focus on symptoms, and testing in the assessment centres will be limited to those who have mild symptoms <u>and</u> are at risk of transmitting COVID-19 to large groups of people, including:

- Those who work in at-risk settings (i.e. hospitals, long-term care)
- Those who reside in vulnerable settings (i.e. homeless, prison, retirement home)
- Those who have been sent by Toronto Public Health (i.e. from areas with active cluster outbreaks)

Everyone else, including those with mild symptoms who have returned from travel, does not need testing unless they get sick enough to go to the Emergency Department.

### Why aren't you testing everyone?

Our aim, with this approach of testing, is to have a more measured, targeted use of existing resources and to limit exposure in testing centres to those who are medically frail or immunocompromised.

### What will happen to those who show up to the assessment centre but don't match the new criteria?

Those who arrive at our assessment centres but do not match the guidelines from the Toronto Region COVID-19 Hospital Operations group (i.e. they do not work in at-risk settings, live in vulnerable settings or have been referred by Toronto Public Health) will be asked to either return home and self-isolate or go to the Emergency Department if their symptoms are severe.

#### *Is it safe to come into the hospital?*

Your safety is our priority. It is safe to access the main hospital and we ask that while you are here you clean your hands frequently. Our Assessment Centres are sealed off and isolated from other areas in the hospital. They will not impact the care you receive regularly at Unity Health.

#### *How will I get my test results?*

Toronto Public Health will follow up with those who are screened in the Assessment Centres.

### When should I go to the Emergency Department (ED)?

Currently, the recommendation is that those who have symptoms of coughing or upper respiratory illness AND severe symptoms of the following – regardless of severity – go to your nearest ED:

- Shortness of breath
- Chest pain
- Weakness
- Lethargy
- Dizziness

Note: symptomatic infants less than six months old should always be assessed in the ED.

#### Will you test children in the assessment centres?

We will screen children who fall under the guidelines. For example, if a child presents to the assessment centre with mild symptoms of COVID-19 and they live in a vulnerable setting, they will be tested at the assessment centre.

#### Are visitors allowed to accompany people who are coming in to be screened in the assessment centres?

Please do not bring visitors into the assessment centre unless needed because the person being screened requires assistance or is a minor. This will help reduce traffic in these spaces.





# Key messages for media

As part of our ongoing COVID-19 response, we are opening two COVID-19 Assessment Centres on Monday, March 16 – one at St. Michael's and one at St. Joseph's – in partnership with Public Health.

The goal of the assessment centre is to provide comprehensive screening, assessment and testing for mildly symptomatic members of the public who either self-present or are referred for assessment by Toronto Public Health. In alignment with new Toronto Region COVID-19 Hospital Operations group guidelines, COVID-19 Assessment Centres will now focus on symptoms, and testing in the assessment centres will be limited to those who have mild symptoms **and** are at risk of transmitting COVID-19 to large groups of people, including:

- Those who work in at-risk settings (i.e. hospitals, long-term care)
- Those who reside in vulnerable settings (i.e. homeless, prison, retirement home)
- Those who have been sent by Toronto Public Health (i.e. from areas with active cluster outbreaks)

Everyone else, including those with mild symptoms who have returned from travel, does not need testing unless they get sick enough to go to the Emergency Department.
